Seminar in Economics (M.Sc.) and Political Science (M.A.)

ECONOMIC POLICY DECISIONS THROUGH THE LENSES OF ECONOMICS AND POLITICAL SCIENCE

Description

Holistic scientific analyses of economic policy reforms combine the observation of political processes with the examination of the substantive content of the reforms. This allows an investigation of whether a reform is suitable for solving specific problems, while also clarifying why certain theoretically more suitable solutions are not politically feasible. The seminar will take an interdisciplinary approach to analyse some German or international recently implemented or discussed economic policy reforms, e.g., the debt brake, the heating law, welfare benefits, energy subsidies, sanctions towards Russia, reforms of the railway system, etc. What economic issues were to be resolved with these reforms? Which effects were to be expected and which, as far as is already known, actually materialised? Why were these reforms implemented in this particular way? Which political processes led to these outcomes? These questions are to be explored in small groups by Economics and Political Science students, who will present and discuss their findings in the block sessions.

Organization

The seminar will take place on Friday, 14 June and Friday, 21 June 2024, most likely from 10:00 to 16:00 in room 00.010. The exact times depend on the number of participants and will be announced in advance on moodle. A preliminary meeting for the selected applicants will take place on Thursday, April 25 at 10:45-12:00 in room 00.010. On Thursday, 2 May at 10:00-12:00 in room 00.010 there will be an additional meeting for students to get to know or recap some theories of the policy process. On Tuesday, 7 May at 10:30-12:00 in room 02.036 another meeting will take place for students to get to know or recap some economic theories of suitable economic policy measures

The presentations will be held jointly by groups of Economics and Political Science students. The group size is variable and depends on the number of participants. The groups will be determined in the preliminary meeting. The seminar thesis has to be written individually, focusing on the respective subject-specific questions. Students who study 50% Economics and 50% Political Science are asked to indicate in the preliminary meeting the subject in which they wish to participate in the seminar.

Seminar Language

The seminar will be held in English.
