"Damages for Negligent Provision of Information"

Information provided by the issuer affects prices at which equity transactions take place. The issuer may be negligent either in spending too little effort at investigating relevant matters or in disseminating available information untruthfully or in both. As a consequence of such negligent behaviour, market participants may suffer losses. Legal systems provide a rather disparate array of remedies without providing a coherent theory that would support the design of these remedies. The present paper propagates a general principle according to which courts may award damages and it identifies conditions under which such damages would generate incentives for the issuer to investigate with sufficient care and to disclose information truthfully. The proposed principle consists of extending the difference hypothesis widely accepted elsewhere to situations of uncertain causation.

"A Dynamic Ellsberg Urn Experiment"*

Two rationality conditions constitute a backbone to justify the link between the conditional and unconditional preferences in decision theory: dynamic consistency, and consequentialism. Dynamic consistency requires that ex ante contingent choices are respected by updated preferences. Consequentialism states that only those outcomes that are still possible can matter for updated preferences. We test the descriptive validity of these rationality arguments by running a dynamic version of Ellsberg's three color experiment.
