"Who should be called to the lab? A comprehensive comparison of students and nonstudents in classic experimental games"

This study exploits the opening of the new experimental lab in Oxford to compare the behavior of students and non-students in a number of classic experimental games. This is the first experiment carried out in the lab and we study the first decisions subjects take. The variety of games enables us to test the robustness of differences in behavior across the two populations and investigate a number of hypotheses for these differences. We find that, across all games, students are more likely to behave as homo-economicus agents than non-students. The differences are particularly large in games involving other-regarding preferences (dictator game, trust game and public good game). Surprisingly, we find that these differences subsist even when controlling for differences in demographics, cognitive ability or risk preferences. In fact, 'being a student' is the only robust predictor of pro-social behavior. Our findings suggest that deviations from the homo-economicus equilibrium found in experiments using students are likely to provide a lower bound for deviations in the general population.

"The Determinants of Cross-Border Tax Information Sharing"

The paper studies the determinants of tax information sharing between the Dutch tax authorities and foreign tax authorities for income tax purposes. To this end, it employs data on tax information sharing on request for a sample of 81 countries covering the period 1992-2005. It is shown that the height of the domestic income tax rate, the size of the marginal cost of public funds, and the share of a country's interest-bearing deposits held abroad increase a country's willingness to engage in information sharing. The presence of automatic bank reporting, which increases the tax authority's ability to monitor the financial transactions of its taxpayers, reduces a country's incentive to engage in tax information sharing. Information sharing is predominantly reciprocal in nature.
