"Rent Shifting, Lagged Entry, and Simple Vertical Restraints"

Wholesale contracts with long-term pricing schemes are of particular concern in legal cases of abuse of market power. Competition authorities complain that an incumbent manufacturer may use the lock-in effect of such long-term contracts with a retailer to make subsequent entry difficult or even prevent it. This paper analyzes an incumbent manufacturer using a long-term contract to shift rent from an entrant who can produce only in later periods. If contracts can only be made contingent on total own quantities, the incumbent's pre-entry (post-entry) quantity will be excessive (inefficiently small) even under the otherwise most general set of contracts. The model permits the analysis of simple vertical restraints widely used in practice. In particular, I show that all-unit discounts outperform two-part tariffs both from the incumbent's and a social point of view, although competition authorities tend to take a more skeptical view towards the former.

"Price Discovery, Causality and Volatility Spillovers in European Union Allowances Phase II: A High Frequency Analysis"

The paper deals with the modeling of the relationship of European Union Allowance spot- and futures-prices within the second commitment period of the European Union Emission Trading Scheme. Based on high frequency data, we analyze causality in the first and the second conditional moments. To reveal long run price discovery we compute the common factor weights proposed by Schwarz and Szakmary (1994) and the information share proposed by Hasbrouck (1995) based on the estimated coefficients of a vector error correction model. To analyze the short run dynamics we perform Granger causality tests. The GARCH-BEKK model introduced by Engle and Kroner (1995) is employed to analyze the volatility transmission structure. We identify the futures market to be the leader of the long run price discovery process whereas a bidirectional short run causality structure is observed. Furthermore, we detect unidirectional volatility transmission from the futures to the spot market at highest frequencies.
