"The Household Welfare Effects of Hurricanes: Evidence from Jamaican Panel Data"

We investigate the impact of hurricanes on household welfare. To this end we combine househould panel data with hurricane destruction index constructed from storm tracks and a wind field model. Our econometric results show that while the average impact is small, rare, large events can have a considerable impact on welfare. To this end, households seem to shift their consumption across goods. Remittances help households buffer some of the shock.
