"Labor Productivity through the Lens of an Electoral Task"

## **Abstracts**

"Labor Productivity through the Lens of an Electoral Task"\*

We measure labor productivity in a simple, uniform, low-skill task, using naturally-occurring data from the 2013 Italian general election and two referenda in 2016. We translate vote-counting times at polling stations across nearly 8,000 municipalities into units of labor productivity. The setting is particularly insightful for regional productivity comparisons as the task involves nearly no technology and requires limited physical and human capital. The task is uniform, as are electoral volunteers' pecuniary incentives. Vote counting rates are highly correlated with provincial level value added per worker in firms. Using a simple development accounting framework, this measure can explain 30% of the firm-level productivity dispersion across Italian provinces and explain nearly half the north- south productivity gap in Italy. We explore potential drivers of our measure labor efficiency; we find that its association with measures of work ethic and trust are particularly strong.
