

"Financial Literacy Externalities"\*

This paper uses unique administrative data and a quasi-field experiment of exogenous refugee allocation in Sweden to estimate effects of exposure to financially literate neighbors. It contributes evidence of causal impact of financial literacy and points to a social multiplier of financial education. Exposure promotes saving for retirement in the medium run and stockholding in the longer run, especially when neighbors have economics or business education, but only for educated or male- headed households. Findings point to knowledge transfer rather than mere imitation. We do not find significant effects on income or employment prospects, except for employment in the financial sector.

"Social Identities and Public Policies: Unintended Effects of Gender Quotas in India"\*

Social identities influence decision-making through the mediating role of social norms. An important limitation of the existing literature is the focus on one social identity at a time. In this paper, we show that failing to account for the multiplicity of identities can importantly affect public policies. Indeed, we exploit the randomized nature of political reservations for women in India, to show that a policy designed along one identity (gender) alters the distribution of the benefits of this policy along another dimension (caste). This is due to the important variation in gender norms across caste groups.

"Do moon phases affect human time allocation?"

Do moon phases affect human behavior? Previous research has been inconclusive. In this paper, I use a different approach to study this question. In particular, I employ more than 123,000 time use diaries to investigate whether individuals allocate their time differently during full moon phases. I do not find evidence that individuals change their sleep duration, but I do find evidence that they spend more time socializing and obtaining goods, and devote less time to educational activities.
