"Clientelistic Politics and Economic Development"

In this paper I provide a more precise understanding of 'political clientelism' than what has been used in most of the existing descriptive literature. Much of the theoretical political-economy literature is on 'pork-barrel' programmatic politics in developed countries, which need to be differentiated from the more usual clientelist politics in poor countries. I also touch on some theoretical ideas relating to the latter and possible empirical ways of testing them. Finally, I provide a discussion of the welfare consequences and institutional dynamics of clientelist practices.

"Deregulation and Vocational Training – The Effect of Germany's Crafts and Trades Reform on Career Trajectories of Apprentices"

This paper examines the effect of deregulating strict occupational licensing requirements on vocational training levels in the crafts and trades sector and its consequences for earnings profiles and early career mobility of young companions. Using aggregate and detailed German administrative data and two quasi-natural experiments, I exploit the crafts and trades reform in 2004, which eliminated the occupational licensing requirements in 53 out of 94 occupations and the temporary suspension of the ordinance on trainer aptitude ("AEVO") from 2004 until 2009. After the reform, a master craftsman degree was no longer necessary to open and run a business and firms were temporarily no longer obliged to obtain a trainer license to engage in vocational training. Using a difference-in-differences approach I find a sizable decrease in training levels and a decline in employment in the deregulated trades after the reform. Further, I observe flatter experience-earnings-profiles for companions in the deregulated trades after the reform, but find few effects in terms of mobility of companions.
