"Collective Punishment and Commitment in Public Goods Games with Imperfect Monitoring"

We experimentally explore the role of punishment in sustaining cooperation in public goods games when there is uncertainty about the contributions of individuals. In particular, we consider sanctioning mechanisms that allow agents to commit to punishment and punishment mechanisms were all group members will be collectively punished. While the ability to commit results in higher contribution levels for standard and collective punishment only sanctioning mechanisms that are collective increase social welfare.

"Who monitors the monitors? Effect of party observers on electoral outcomes"

We investigate whether monitoring by individuals with preferences over the outcome of the supervised task interferes with the task's process: Does the monitors' presence bias the results in favor of their own preferences? To do so, we construct a novel dataset from the raw voting records of the 2011 national elections in Argentina. We exploit a natural experiment to show that electoral observers with partisan preferences cause a 1.7% to 7% increase in the vote count for the observers' preferred party. This bias, which appears under various electoral rules, occurs mainly in municipalities with lower civic capital (Guiso et al. (2011)) and weakens the accountability role played by elections.

"Monotone Stochastic Choice Models: The Case of Risk and Time Preferences"

Suppose that, when evaluating two alternatives \$x\$ and \$y\$ by means of a parametric utility function, low values of the parameter indicate a preference for \$x\$ and high values indicate a preference for \$y\$. We say that a stochastic choice model is monotone whenever the probability of choosing \$x\$ is decreasing in the preference parameter. We show that the standard use of random utility models in the context of risk and time preferences may sharply violate this monotonicity property, and argue that their use in preference estimation may be problematic. We then establish that the alternative random parameter models, in contrast, are always monotone. We show in an empirical application that standard risk-aversion assessments may be severely mis-estimated.
