"Power Politics: Electoral Cycles in German Electricity Prices"

We provide evidence that German public energy providers, over which municipality-level politicians hold substantial sway, systematically adjust the pricing of electric energy in response to local electoral cycles. The documented pattern is in line with both, an artificial reduction in prices before an election that needs to be countermanded by future price increases, and an artificial postponement of market-driven price increases until after the election is over ics and Politics Seminar.

"Decentralized Authority and the Dynamic Fragmentation of Regional Party Systems"

The stability of political systems crucially hinges on the format of party systems. Both, too little and too much fragmentation is considered damaging for democracies. One of the most important trends in political systems is the decentralization of authority to subnational levels. We analyze the role of decentralization reforms for long-term fragmentation dynamics on the regional level. We argue that fragmentation first decreases after decentralization because specific parties are held responsible to have delivered authority and accordingly benefit from achiever premiums. Afterwards, achievers start to lose grip on regional voters and fragmentation sets in. We empirically test this proposition using a dataset on regional election results consisting of more than 100.000 observations with growth models and demonstrate that achievers benefit systematically from decentralization in the first three elections after reform. This dynamic pattern is confirmed using aggregated regional fragmentation data as the dependent variable. Overall, the decentralization trend of the last decades can be seen as a short term mitigation of rising political fragmentation but in the long run decentralized authority undermines the cohesion of party systems.

"Employment Protection and Fixed Term Contracts: Evidence from a German Reform"

I evaluate the effects of a 2001 reform in Germany, which has changed the ability of larger firms to establish fixed-term employment contracts. After the reform hiring employees on fixed-term contracts became relatively easier for firms above the employment protection threshold of 5 employees. Using a basic differences-in-differences approach that compares firms below and above the official employment protection threshold, I find that the reform has led to a rise in the use of fixed-term contracts but has not increased employment.
