#### Content

This course provides an overview of development economics, with particular emphasis on macro issues in economic development. The most important topics to be covered are the measurement, history and meaning of economic development, empirical growth research, migration, trade, and capital flows, development cooperation, and international organizations.

After successful completion, students will be able to understand why countries are at different stages of economic development and how such development can be measured using different metrics. They can explain how historical income differences between countries developed, and can apply theories of growth and trade to evaluate the constraints faced by developing countries. They can critically evaluate the role of population growth as well as migration, institutions, foreign aid, and international organizations in affecting development, and they will be able to employ statistical methods to evaluate determinants of economic development.
