"Elections and de facto Expenditure Decentralization in Canada"*

This paper empirically investigates the underlying determinants of expenditure decentralization, based on the predictions of a new political economy model of partial expenditure decentralization. The analysis is based on an agency model, in which two levels of government are involved in the provision of a public good and voters are imperfectly informed about each government's contribution to the good, creating a shared accountability problem. Under shared expenditure responsibility, the degree of decentralization is endogenous and depends on the relative political conditions prevailing at each level of government. Consistent with the model's predictions, empirical results from a panel of Canadian provinces show that decentralization in a province increases with the electoral strength of the provincial government and decreases with the electoral strength of the federal government, in addition to being affected significantly by the partisan affiliation of both levels of government. A series of alternative empirical specifications, including an IV regression exploiting campaign spending data, are presented to assess the robustness of these results.

"The Effects of Voting Costs on the Democratic Process and Public Finances"

Increasing the attractiveness of voting is often seen as a remedy for unequal participation and the influence of special-interest groups on public policy. However, lower voting costs may also bring less informed citizens to the poll, thereby inviting efforts to sway these voters. We substantiate this argument in a probabilistic voting model with campaign contributions. In an empirical analysis for the 26 Swiss cantons, we find that lower voting costs due to postal voting are related to higher turnout, lower average education and political knowledge of participants as well as lower government welfare expenditures and lower business taxation.

"Is There a Home Bias in Sovereign Ratings?"

Credit rating agencies are exposed to the criticism that their sovereign ratings decisions do not accurately reflect the economic and political fundamentals of rated countries. This article discusses how the headquarter location of rating agencies and their major shareholders' nationality might influence rating outcomes. Using data from nine agencies based in six countries, we investigate empirically whether there is systematic evidence for a home bias in sovereign ratings. Specifically, we use dyadic panel data to test whether, all else being equal, agencies assign better ratings to their home country, as well as to countries economically, politically and culturally aligned with it. Our results provide empirical support for such a home bias in sovereign ratings, which becomes more accentuated since the onset of the Global Financial Crisis and appears to be driven by economic and cultural ties, not geopolitics.
